



- Agency Budgets
- Grant Management Capacity
- 501(c)(3)
- Certificate of Good Standing

THREE-YEAR PLAN - YEAR ONE

- Forecast of VOCA Funding
- Goals and Objectives:
 - October I, 2024 September 30, 2027
 - Kansas Implementation Plan
 - ► Pre-Application Webinar July 11, 2022 (37:50 59:22)
- Budget:
 - October 1, 2024 September 30, 2025

MATCH REQUIREMENT

- Match Requirement in Effect
 - 20 percent of Total VOCA Project
 - i.e. 100% of VOCA project supported by 80% federal VOCA funds + 20% match
 - Exceptions:
 - Federally-recognized American Indian Tribes Exempt from Match Requirement
 - Match Waiver Requests Properly Executed/Justified; Formally Approved by KGGP

MATCH REQUIREMENT

- Match Requirement Criteria
 - Cash (non-federal funds) or In-kind
 - Same Conditions as Federal Funds
 - Grant Portal Budget inclusive of Total VOCA Project
 - Reimbursement Contingent on Meeting Match Requirement

MATCH WAIVERS

- Kansas VOCA Match Waiver Policy, updated July 3, 2024
- Full or Partial Waivers (anything less than 20% match)
 - I. Project Narrative, subheading Match Waiver Request
 - Provide supported justification of match waiver request
 - Specify if request is for a full match waiver or, if requesting partial waiver, specify proportion to be matched
 - e.g. 90% federal VOCA funds / 10% match
 - 2. Budget reflective of match waiver request
 - Federal VOCA line items and match line items in proportion to request

THREE-YEAR PLAN — YEARS TWO AND THREE

- 2026 Application Budget:
 - October 1, 2025 September 30, 2026
 - Match included or waiver requested

- 2027 Application Budget:
 - October I, 2026 September 30, 2027
 - Match included or waiver requested
