VOCA Fix Legislation

- “The VOCA Fix” (34 U.S.C. 20103)
- Effective July 22, 2021
- Match shall be waived

OVC Guidance

- Office for Victims of Crime Guidance
 - Released September 20, 2021
- “Unmet” match shall be waived
 - Determined at time of waiver

KGGP Policy Update

- August 23, 2021: All 2021 VOCA Subgrantees instructed to report no further match on August and September FSRs
- Update Effective September 27, 2021
 - Posted on KGGP website
- October 1, 2021: All 2021 VOCA Subgrantees with “unmet” match provided detailed instructions to implement the automatic match waiver

Match Waiver Acceptance

- Steps to Take:
 - By October 15, 2021, submit revised budget
 - Match allocated to line items per July FSR and amount waived
 - No budget changes to federal funds fields
 - Budget Summary totals remain unchanged
- Considerations:
 - Year-end FSR, SAR Part 1, and PMT SAR Part 2 must reconcile
 - Final quarter data includes match-related services/statistics for July only

Match Waiver Declination

- Steps to Take:

- By October 11, 2021, notify KGGP of decision
- Revise August FSR to report match
- Prepare September FSR to report match

- Considerations:

- Subgrantee must meet the 20 percent match requirement to receive full reimbursement *
 - *or current approved match percentage if prior waiver in place
- All match subject to audit (as if waiver not offered)
